The Commission on Accreditation of Allied Health Education Programs (CAAHEP) is pleased to inform you of its vote on **May 16, 2014** to award **continuing accreditation** to the Surgical Technology program at Hutchinson Community College, Hutchinson, KS.

The recent peer review conducted by the Accreditation Review Council on Education in Surgical Technology and Surgical Assisting (ARC/STSA) and CAAHEP's Board of Directors recognizes the program's substantial compliance with the nationally established accreditation Standards. The progress report, submitted as a single "seamless" electronic/digital document on a CD-ROM, DVD, or external drive [stick drive, thumb drive, USB drive, etc.] for documentation in excess of 20 pages, should be received by the ARC/STSA on or before close of business (4:30 PM, Mountain) on the due date specified above. 
